

**REQUEST FOR PROPOSALS  
PARK WALKWAY FENCING PROJECT  
SMOKY HILL METROPOLITAN DISTRICT**

Project Overview

Smoky Hill Metropolitan District, a Special District located in Arapahoe County, is requesting bids for a fencing project. Walkway entrances currently fenced with chainlink or split rail fencing into 4 neighborhood parks will be replaced. Also fencing along two drainage areas in the neighborhood will be replaced. All areas are within the Smoky Hill subdivision (see map with work areas attached)

Time Frame

Work to be started April or May 2021 and completed no later than June 30, 2021

Materials

Fencing to be black vinyl chainlink, 4 foot high, with top and bottom black metal rails. Fence posts to be black metal and cemented into ground

Scope of Work

Fencing on each side of the walking paths/entryways into 4 parks and along 2 drainage areas. In some areas, bushes or foliage will need to be cut back away from fences, so this should be factored into the bid. The table below gives the approximate feet of fencing to complete the project. We recommend in-person site visits to see actual scope of work. No temporary fencing will be required. No gates will be required.

Prospector Park Open Space	2 walkway entrances	206 feet total

Award announced: March 5, 2021


